STATUTE AND PENALTY

Rhode Island Statute, Title 31 R.I. Gen. Law
 § 31-51 – School Bus Safety Enforcement Act

The penalty for the violation shall be a civil fine paid in person at the Rhode Island Traffic Tribunal and/or suspension of his or her driving license for a period not to exceed thirty (30) days.

PROCEDURE

This is a civil traffic violation which will be heard at the Rhode Island Traffic Tribunal located at 670 New London Ave, Cranston, Rhode Island 02920. Please be advised that upon receipt of a Summons you must appear in person with the Summons at the Rhode Island Traffic Tribunal and either pay the civil fine in accordance with the provisions of §31-51-2.2; proceed under §31-51-5(c); or elect to stand trial for the alleged violation.

TRANSFER OF LIABILITY

In the event that the registered owner or lessee of the vehicle operated in violation of this chapter was not the operator of the vehicle at the time of the violation, the registered owner or lessee shall either:

- (1) Accept responsibility for the violation by paying the fine; or
- (2) Upon receipt of the notice of the violation, provide the issuing authority, within twenty (20) days of the date of issuance, the name and address of the individual operating the vehicle at the time which the violation occurred.

To transfer liability the driver of the vehicle needs to appear in person with the summons and/or supplemental summons to the issuing agency - North Providence Police Department located at 1835 Mineral Spring Ave., North Providence, RI 02904.
